(Only Ration card will not be accepted as proof for BPL category)

POINTS TO BE KEPT IN MIND WHILE FILLING THE ONLINE REGISTRATION FORM FOR ADMISSION IN CLASS-I

- In Differently Abled Column fill YES only if the Child is Handicapped and have valid Disability Certificate.
- In Caste Category if choosing OBC- Non-Creamy Layer please ensure you have valid OBC-NCL Certificate. This certificate should be issued on or after 01.04.2019 (Socially Educationally Backward Classes (SEBC) certificate will not be accepted in lieu of OBC-NCL Certificate)
- In Single Girl Child (SGC) (Applicable for Twin Girls also) column if you are filling YES please be sure that you have only Girl Child (Twin Girls) having no Male/Female Sibling.
- 4. In Family Income Group column if you are choosing "E conomically Weaker Section" please ensure that you have valid EWS Certificate i.e. "Income & Asset Certificate to be produced by E conomically Weaker Section" issued on or after 01.04.2021, (It selected for admission you may have to submit the EWS Certificate issued after 01.04.2022) Only Income Certificate will not be accepted in lieu of it.
- In Family Income Group if you are choosing "Below Poverty Line (BPL)" please ensure that you have the following documents.
 - (a) BPL Card, if available in the name of the parent of the child, but lapsed as on date, this can be countersigned by the BDO of the locality of rural areas/Executive Officer of NAC of Municipality areas to validate the card along with Low Income Certificate/ EWS Certificate/Labour Card

OR

(b) PHH Ration Card (New) + Old BPL Card + Low Income Certificate/ EWS Certificate/Labour Card

OR

(c) Antodaya Anna Yojana Card + LowIncome Certificate/ EWS Certificate

AND

An Affidavit to the effect that as on date the Parent and his family belongs to BPL Category and Low-Income Group

- In Residential Address column the address filled by the parent is final and in later stage
 it will not be changed. The parent has to submit the proof of residence accordingly. The
 following documents will be accepted as residence Address proof.
 - Electricity bill/Telephone bill/gas connection or gas delivery receipt/Aadhar Card/bank Pass Book /Quarter Allotment order copy (if residing in govt. allotted quarter) etc. in which the address is mentioned (This should be in the name of either of the parents).
 - If residing in Rented House Rent agreement along with electricity bill of the house owner.
- Those who are applying under RTE should ensure that the radial distance between the
 residential address filled in the Online Registration Form and the School is less than or
 equal to 5 KM.
- 8. Service Category: Please fill the correct service category. Those who are not Central/State govt., Central/State public sector undertaking (PSU) employee. Please choose category-6(e.g. business man, self-employed, private sector employee have to choose service Cat-6).
- NOTE: (a) Different performa for admission are available in Vidyalaya web site http://rourkela.kvs.ac.in in announcement section under the heading of admission performa may be downloaded as used.
- (b) If anyone want to modify any data on the already submitted application please log in with your log in code and cancel the application and make necessary modification.
